Karen Merchant – commented that she is an educator, child has an IEP, IEP is not being met, staff is using the same bathroom at the students, asking the Board where is the principal

Melissa Cabrera – first year at the school, child's IEP is not being met, child is not being challenged, child is not in a mainstream class and is in a classroom with other students with IEPs, has given the staff the tools to help work with her child, not happy with the way the staff talks to the students

Gwendolyn Gunn-Ingram – commented about condition of the 7th ave building, no phone, no buzzer, no using the gym at this time, no white boards, lights are sporadic, commented about hiring more staff or working with staff to develop better relations

Kyreesha Thomas – commented about struggle at the end of last year with students being let down, doesn't want to see that happen again, feels more preparation need to be done to help students transition out of University Heights

Tyola Hughes – three weeks of school and has already had to address with the school a teacher putting hands on the student, feels student is getting put out of classroom too often missing classwork, parent fees uneasy, feels her child is getting bullied and not being talked to properly
